4. Author agrees to hereby release, discharge and agree to make harmless UAA, its representatives, assigns, employees or any person or persons, corporation or corporations, acting under its permission or authority for whom might be acting including any firm publishing and/or distributing the finished product, in whole or in part, from and against any liability as a result of any distortion, alteration, optical illusion, or use in composite form, either intentionally or otherwise, that may occur or be produced in the taking, processing or reproduction of the finished product, its publication, distribution, or broadcast of the same event should the same subject me to ridicule, scandal, reproach, scorn, or indignity.
